I, ROSS D. MURRAY, being duly sworn, depose and say:

1. I am employed as a Vice President of Securities by Gilardi & Co. LLC ("Gilardi"), located at 1 McInnis Parkway, Suite 250, San Rafael, California. Pursuant to this Court's October 11, 2022 Order Preliminarily Approving Settlement and Providing for Notice ("Notice Order") (<u>NYSCEF No. 193</u>), Gilardi was appointed as the Claims Administrator in connection with the proposed Settlement of the above-captioned action (the "Action"). I oversaw the notice services that Gilardi provided in accordance with the Notice Order.

2. I submit this affidavit as a supplement to my earlier affidavit, the Affidavit of Ross D. Murray Regarding Notice Dissemination, Publication, and Requests for Exclusion Received to Date (the "Initial Mailing Affidavit") (<u>NYSCEF No. 200</u>). The following statements are based on my personal knowledge and information provided to me by other Gilardi employees and if called to testify I could and would do so competently.

UPDATE ON DISSEMINATION OF THE CLAIM PACKAGE

3. As more fully detailed in the Initial Mailing Affidavit, as of December 13, 2022, Gilardi had mailed 5,931 copies of the Court-approved Notice of Proposed Settlement of Class Action (the "Notice") and Proof of Claim and Release form (the "Proof of Claim") (collectively, the "Claim Package") to potential Settlement Class Members and their nominees. *See* Initial Mailing Affidavit, ¶10.

4. Since December 13, 2022, Gilardi has mailed an additional 7 copies of the Claim Package in response to requests from potential Settlement Class Members, brokers, and nominees and as a result of mail returned as undeliverable for which new addresses were identified and remailed to those new addresses. Therefore, as of January 23, 2023, Gilardi has mailed a total of 5,938 Claim Packages to potential Settlement Class Members and nominees.

LACK OF EXCLUSION REQUESTS AND OBJECTIONS RECEIVED TO DATE

5. Pursuant to the Notice Order, the Notice informed potential Settlement Class Members that written requests for exclusion from the Settlement Class must be mailed to *Luckin Convertible Notes Settlement*, Claims Administrator, EXCLUSIONS, c/o Gilardi & Co. LLC, P.O.

Box 5100, Larkspur, CA 94977-5100, such that they are postmarked no later than December 27, 2022. At the time of the Initial Mailing Affidavit, Gilardi reported that it had not received any requests for exclusion in connection with this Settlement. *See* Initial Mailing Declaration, ¶15.

6. Since the Initial Mailing Affidavit was executed, and as of the date of this affidavit, Gilardi has not received any requests for exclusion.

7. Although the Notice (which also included the proposed Plan of Allocation ("POA")) instructed Settlement Class Members to submit objections to the Settlement, POA, or the Fee and Expense Application to the Court and to counsel (rather than to Gilardi), at the time of the Initial Mailing Affidavit, Gilardi reported that it had not received any objections. *See* Initial Mailing Affidavit, ¶16.

8. Since the Initial Mailing Affidavit was executed, and as of the date of this affidavit, Gilardi has received one piece of correspondence which styles itself as an objection.
